



A Prayer of Renunciation

New Age, Kundalini & Occult Ritual Practices

Including Red Lodge & Associated Spiritual Bondage

Presented in the Courts of Heaven | Curse Breaking | Generational Freedom | Divorce Certificate | Betrothal to Christ

This prayer is intended for those who have been involved — knowingly or unknowingly — in New Age spirituality, kundalini practices, women's mystery traditions, Red Lodge rituals, moon ceremonies, menstrual blood rites, sacred sexuality, or any associated occult or esoteric practices.

Before beginning, find a quiet place. It is recommended to pray this with a trusted believer or deliverance minister present. Read each section aloud, sincerely and from your heart.

"If we confess our sins, He is faithful and just to forgive us our sins and to cleanse us from all unrighteousness." — 1 John 1:9

"Therefore submit to God. Resist the devil and he will flee from you." — James 4:7

Part One: Entering the Courts of Heaven

Robert Henderson's teaching on the Courts of Heaven reveals that God has established a heavenly judicial system where legal cases are heard and verdicts rendered. Satan operates as an accuser (Revelation 12:10) who presents legal claims against us based on sin, ancestral covenants, and agreements made with demonic powers. Before deliverance can be fully received and sustained, these legal grounds must be addressed in the Courts of Heaven. The following section is a formal legal presentation before the Courts of Heaven. Speak it with faith as one who has been given the right to approach the throne of grace (Hebrews 4:16) and to stand before the Judge of all the earth (Hebrews 12:23).

"For the accuser of our brothers and sisters, who accuses them before our God day and night, has been hurled down." — Revelation 12:10



A. Approaching the Court

Father God — Righteous Judge, Ancient of Days — I come before Your Courts in the Name of Jesus Christ, my Advocate (1 John 2:1). I approach not on the basis of my own righteousness, but entirely on the merit of the blood of Jesus Christ, which speaks a better word than the blood of Abel (Hebrews 12:24). I ask that Your Courts be now convened and that my case be heard.

I acknowledge You, Lord Jesus, as my High Priest who has entered the Most Holy Place on my behalf. I acknowledge the Holy Spirit as my Helper who intercedes according to the will of God. I stand in this Court as Your child, redeemed by Your blood, and I invoke my right to legal standing before You.

B. Silencing the Accuser

Father, I acknowledge that the enemy has held legal ground against me and my family line through involvement in occult practices, New Age spirituality, kundalini, Red Lodge rituals, moon ceremonies, blood rites, and sacred sexuality. I do not contest the accuser's right to present these charges — I agree that they are true. But I come today to answer every charge through the blood of Jesus Christ.

I present the blood of Jesus as my evidence, my plea, and my defence. As Zechariah 3 shows us — when Joshua stood before the Lord in filthy garments with Satan at his right hand to accuse him — the Lord rebuked the accuser and clothed Joshua in clean robes. I ask for that same verdict today. Let every charge brought against me through these practices be answered and silenced by the blood of the Lamb.

C. Presenting Evidence: Repentance and Confession

I now present my repentance as legal evidence before this Court. I confess it fully, honestly, and without reservation as sin against You — the one true God. I acknowledge that these practices gave the enemy legal access to my life, my body, my mind, my family, and my generational line. I take full responsibility for the doors I opened and I repent on behalf of myself and my ancestors. On the basis of 1 John 1:9, I ask that this Court record my confession and grant me full forgiveness and cleansing. Let the blood of Jesus blot out every legal record held against me in the spirit realm.

Part Two: Opening Preparation

A. Acknowledge the Lordship of Jesus Christ

Heavenly Father, I come before You in the Name of Jesus Christ, Your Son and my Lord and Saviour. I acknowledge that Jesus Christ came in the flesh, died on the cross for my sins, rose bodily from the dead,



and is seated at Your right hand with all authority in heaven and on earth. I confess that He is Lord over every area of my life — my spirit, soul, and body.

I stand today under the authority of the blood of Jesus Christ, the finished work of the cross, and the resurrection power of the Holy Spirit. I ask You, Holy Spirit, to guide this time of prayer, to reveal what needs to be renounced, and to bring complete freedom and healing to every part of my being.

B. Repentance and Invitation

Lord, I come to You in genuine repentance. I acknowledge that my involvement in these practices was sin — whether I entered knowingly or in ignorance. I take full responsibility. I do not blame others, though I acknowledge that some of these doors were opened through others' influence, family lines, or spiritual deception. I ask for Your forgiveness and the cleansing of my conscience through the blood of Jesus.

Part Three: Renunciation of New Age Spirituality

Speak the following declarations aloud. Each section contains renunciation — the breaking of spiritual ties — and repentance, which forms the legal evidence presented before the Courts of Heaven.

A. Renunciation

In the Name of Jesus Christ and by His authority, I renounce all involvement with New Age spirituality in every form. I renounce the belief that I am my own god or that I hold divine power within myself apart from the one true God — Father, Son, and Holy Spirit.

I renounce the New Age gospel of self-enlightenment, higher consciousness, and spiritual evolution. I renounce all contact with spirit guides, ascended masters, inner guides, higher selves, light beings, and any spirit entity that presented itself as benevolent but was not sent by the Holy Spirit.

I renounce chakra work, chakra opening, chakra balancing, and chakra alignment. I renounce all energy healing practices, including Reiki, pranic healing, quantum healing, crystal healing, and similar modalities. I renounce all attunements, initiations, and empowerments received through these practices.

I renounce visualisation practices involving altered states, journeying to inner realms, or meeting spirit beings. I renounce astral projection, lucid dreaming for spiritual access, remote viewing, and astral travel. I renounce all involvement with tarot, oracle cards, runes, pendulums, automatic writing, and any form of divination. I renounce all readings received and given.



I renounce any vows, oaths, or covenants I made — whether consciously or unconsciously — to any New Age teacher, group, collective, or spiritual entity. I declare those vows null and void under the authority of the blood of Jesus Christ.

B. Repentance

Lord Jesus, I repent for participating in these practices. I repent for placing my trust in spiritual systems that did not honour You. I repent for seeking supernatural experience, knowledge, and power outside of Your Word and Your Spirit. I repent for any way these practices dishonoured You, opened doors to the enemy, and brought harm to myself and those connected to me. Forgive me, Lord. Cleanse me by Your blood.

Part Four: Renunciation of Kundalini Practices

"For our struggle is not against flesh and blood, but against the rulers, against the authorities, against the powers of this dark world." — Ephesians 6:12

Kundalini is described in Hindu and occult tradition as a serpent spirit coiled at the base of the spine, activated through yoga, breathwork, meditation, and initiation. Its manifestations can open the door to demonic oppression. The following renunciations address this directly.

A. Renunciation

In the Name of Jesus Christ, I renounce all involvement with kundalini energy, kundalini awakening, and kundalini rising in every form. I renounce any activation of the kundalini force through yoga, breathwork, pranayama, rebirthing, meditation, sound healing, plant medicines, or spiritual initiation.

I renounce the serpent spirit behind kundalini. I declare that my spine, nervous system, and every part of my body belongs to the Holy Spirit alone. I command every kundalini manifestation to cease and leave my body now in Jesus' Name.

I renounce yoga in all its forms as a spiritual practice — Hatha, Kundalini, Tantric, Ashtanga, and any system rooted in Hindu or occult philosophy. I renounce the postures, breathwork, and mantras as acts of devotion to gods other than the God of the Bible.

I renounce all meditation practices involving mantra repetition, transcendental meditation, Buddhist emptying of the mind, and any practice that opened my mind to spiritual influences outside of the Holy Spirit. I renounce holotropic breathwork, shamanic breathwork, and rebirthing as means of accessing



altered states. I renounce plant medicines — including ayahuasca, psilocybin, peyote, San Pedro, and ibogaine — used for spiritual purposes. I renounce every covenant or spiritual entity encountered through these substances and I break every soul tie formed during those experiences.

B. Repentance

Lord Jesus, I repent for allowing the serpent spirit entry through these practices. I repent for seeking spiritual experience through my body and breath rather than through Your Holy Spirit. I repent for every session, initiation, and practice that welcomed kundalini and occult energy into my body. I ask You to cleanse my nervous system, my spine, and every cell of my body by Your blood. Forgive me, Lord.

Part Five: Renunciation of Red Lodge, Moon Rituals & Women's Mystery Traditions

A. Renunciation — Goddess Worship

In the Name of Jesus Christ, I renounce all worship of, devotion to, and spiritual connection with goddess figures — including the Triple Goddess, the Divine Feminine, Isis, Kali, Lilith, Hecate, Astarte, Diana, Gaia, the Great Mother, and any other goddess entity to whom I have prayed, made offerings, or given allegiance.

I renounce the belief system that elevates feminine energy as a divine and autonomous spiritual force. I declare that my femininity is a gift from the God of the Bible and belongs to Him alone for His glory.

B. Renunciation — Red Lodge and Blood Rites

I renounce all involvement with Red Lodge practices, Red Tent spirituality, and any ritual framework that uses menstrual blood as a source of spiritual power, a tool of blessing or cursing, an offering to spirits or the earth, or a means of spiritual initiation. I renounce any ritual in which I offered my own blood to the earth, a deity, a spiritual community, or as part of a ceremony. I break every covenant made through blood rites and every spiritual tie formed through shared blood practices.

I renounce any initiations, blessings, or spiritual transfers received through Red Lodge circles, women's mystery circles, or red tent gatherings. I renounce the spiritual authority I was given or assumed within these circles. I lay it all down at the feet of Jesus.



C. Renunciation — Moon Rituals and Paganism

I renounce all moon rituals, new moon ceremonies, full moon circles, and any practice that worshipped, honoured, or spiritually aligned with the moon as a deity or source of power. I renounce the drawing down of the moon, the invoking of lunar goddesses, the use of moonwater, moon altars, and all lunar ritual practices.

I renounce all involvement with Wicca, witchcraft, paganism, neo-paganism, shamanism, and earth-based spirituality. I renounce the casting of spells in any form. I renounce the use of crystals, herbs, candles, sigils, and ritual objects as tools of occult power. I renounce all altars I constructed or participated in creating. I declare those altars spiritually dismantled and every covenant they represented broken.

D. Repentance

Lord Jesus, I repent for participating in these mystery traditions and feminine occult systems. I repent for allowing the enemy to distort and corrupt my God-given womanhood through these rituals. I repent for the blood rites, the moon worship, the goddess invocations, and every ceremony that honoured powers other than You. I repent for the ways I led others into these practices. Forgive me, Lord. I ask You to restore my identity as Your daughter and to heal every part of my womanhood that was used in these rituals.

Part Six: Renunciation of Sacred Sexuality and Sexual Occult Practices

"Flee sexual immorality. Every other sin a person commits is outside the body, but the sexually immoral person sins against his own body." — 1 Corinthians 6:18

A. Renunciation

In the Name of Jesus Christ, I renounce all involvement with Tantra — including Hindu Tantra, neo-Tantra, sacred sexuality, and any system that uses sexual energy as a path to spiritual enlightenment or power. I renounce every teaching, practice, course, or initiation I received in these areas. I renounce the use of sexual energy for spiritual purposes outside of God's design for covenant marriage. I renounce every sexual ritual I participated in and every spirit entity encountered through sexual occult practice.

I renounce and break every ungodly soul tie formed through sexual practices connected to occult or spiritual systems. In the Name of Jesus, I call back every part of my soul given away through these experiences. I send back every fragment of another person's soul that attached to me. I declare my soul



reunited, whole, and cleansed by the blood of Jesus Christ. Father, I ask You to sever — by the sword of Your Spirit — every cord and ungodly attachment formed through these sexual and spiritual practices.

B. Repentance

Lord Jesus, I repent for allowing my body — which is the temple of the Holy Spirit — to be used in sexual occult practices. I repent for every act of sacred sexuality, for every ritual involving my body, and for every ungodly soul tie formed through these experiences. I repent for dishonoring Your design for sexuality and intimacy. Forgive me, Lord. Cleanse my body, soul, and spirit. Restore the sanctity of my physical being.

Part Seven: Ancestral Renunciation and Covering Children

A. Generational Repentance and Renunciation

In the Name of Jesus Christ, I repent on behalf of myself and my family line — going back as many generations as necessary — for all involvement with occult practices, goddess worship, blood rites, witchcraft, kundalini, Red Lodge practices, sacred sexuality, and New Age spirituality. I repent for any covenants made by my ancestors that opened spiritual doors into my family line.

I declare, by the authority of the blood of Jesus Christ, that every generational curse and every inherited spiritual bondage connected to these practices is now broken. Galatians 3:13 declares that Christ has redeemed us from the curse of the law, having become a curse for us. I receive that redemption now, for myself and for my descendants.

I renounce every generational agreement with the occult, with serpent spirits, with goddess spirits, and with any other demonic entity that has had claim over my family line. I serve them notice that their legal ground is removed in Jesus' Name.

B. Covering Children and Future Generations

Father God, in the Name of Jesus Christ, I stand in intercession for my children, grandchildren, and all future generations. I repent on their behalf for any doors opened through my participation in these practices that gave the enemy legal claim over them. I break every curse, every spiritual inheritance, and every demonic assignment intended to transfer to them through my involvement.

I cover my children and descendants with the blood of Jesus Christ. I declare that the generational line of occult and New Age involvement stops with me this day. I pray for a complete severance between my



children and every demonic entity that sought access through these practices. Let the blood of Jesus be applied to the doorposts of their lives, their minds, their bodies, and their futures.

I declare that my children and descendants are heirs of the blessing of Abraham through Jesus Christ (Galatians 3:14). They belong to God. No weapon formed against them through generational occult ties shall prosper (Isaiah 54:17). I release blessing, not curse, over every generation that follows me.

Part Eight: Courts of Heaven — Breaking Curses and Cancelling Legal Claims

Having made our confessions and renunciations, we now formally petition the Court for the breaking of every curse and cancellation of every legal claim. This is done in the understanding that Jesus Christ has already borne every curse at the cross (Galatians 3:13), and we are activating that legal verdict in the heavenly realm.

"Christ redeemed us from the curse of the law by becoming a curse for us — for it is written, 'Cursed is everyone who is hanged on a tree.'" — Galatians 3:13

A. Presenting the Blood as Evidence

Righteous Judge, I present the blood of Jesus Christ as the supreme legal evidence in this Court. The shed blood of the Son of God speaks on my behalf — it testifies to a completed atonement, a paid penalty, and a satisfied justice. Every sin I have confessed today — mine and my ancestors' — has been paid for at Calvary. The accuser has no legal ground that the blood of Jesus has not already covered.

I ask this Court to receive my repentance and the blood of Jesus as full payment for every legal charge. I ask that every document, every scroll, every legal record held in the spirit realm against me — pertaining to New Age, kundalini, Red Lodge, moon rituals, blood rites, sacred sexuality, and all associated practices — be stamped with the blood of Jesus and marked: PAID IN FULL.

B. Petitioning for the Breaking of Curses

On the basis of Galatians 3:13 and the atoning work of Christ, I petition this Court for the formal breaking of every curse that has operated in my life and family line through these practices. I name before this Court the following categories of curses and ask for their complete dissolution:

Curses of spiritual blindness and deception that came through New Age initiation. Curses of serpentine bondage and kundalini oppression through yoga, breathwork, and kundalini activation. Curses of



covenant with goddess spirits and lunar entities through Red Lodge rituals, moon ceremonies, and blood rites. Curses of sexual defilement and soul fragmentation through sacred sexuality and tantra. Curses of witchcraft and divination through spellwork and occult ritual. Every generational curse passed down through my family line connected to any of the above.

I petition this Court: let every one of these curses be formally broken by the verdict of this Court on the basis of the blood and resurrection of Jesus Christ. Let every legal instrument that sustained these curses be cancelled, annulled, and rendered void. Let the sentences imposed — including sickness, mental torment, spiritual oppression, relational dysfunction, financial blockage, and generational bondage — be lifted and reversed.

C. Cancelling Legal Claims Over Children

Righteous Judge, I present before this Court my children and all future generations of my family line. I acknowledge that my sin gave the enemy legal access not only to me but potentially to them. I repent fully on their behalf. I petition this Court for the formal cancellation of every demonic legal claim, contract, and assignment over my children and descendants — claims made on the basis of my occult involvement or my ancestors' involvement. Let the blood of Jesus be applied as a legal seal over their lives. Let this Court issue a verdict that they are free — free from inherited bondage, free from generational curses, free from demonic assignment — and that they belong to the God of Abraham, Isaac, and Jacob.

D. Receiving the Verdict

I now receive, by faith, the verdict of this Court: I am forgiven. I am cleansed. The curses are broken. The legal ground is removed. The enemy's claims are cancelled by the blood of Jesus Christ. Every accusation is answered. Every charge is dismissed. The Judge of all the earth has ruled in my favour — not because of my merit, but because of the merit of Jesus Christ, my Advocate. I declare this verdict over my life, my children, and my generational line. What God has set free is free indeed. I walk in this verdict from this day forward.

Part Nine: Command, Cleansing, and Expulsion

A. Command to All Spirits

In the Name of Jesus Christ of Nazareth, by the authority of His blood and His resurrection, and on the basis of the verdict just rendered in the Courts of Heaven, I address every demonic spirit that has gained access to my life through the practices I have renounced — every unclean spirit, kundalini spirit, serpent



spirit, goddess spirit, spirit of witchcraft, spirit of divination, spirit of Jezebel, spirit of Python, spirit of Leviathan, spirit of sexual perversion, lunar spirit, earth spirit, and spirit of false religion:

The Courts of Heaven have ruled against you. You no longer have legal ground. The covenants are broken. The vows are cancelled. The initiations are renounced. The blood of Jesus has been applied. You are commanded to leave — now — in the Name of Jesus Christ. Take everything with you — every effect, every assignment, every attachment, every implant — and go to where Jesus sends you. I forbid you to return.

B. Invitation to the Holy Spirit

Holy Spirit, I invite You now to fill every place that has been vacated. Fill me with Your presence, Your peace, Your power, and Your truth. Heal every wound — in my spirit, soul, and body — created through these practices. Restore what was stolen. Rebuild what was broken. Renew my mind according to the Word of God.

Father, place a guard over every doorway cleansed today. Seal me with the Holy Spirit of promise (Ephesians 1:13). Let the blood of Jesus be applied to every threshold of my life. I declare that I am a new creation in Christ — the old has gone, the new has come.

Part Ten: The Divorce Certificate — Severing All Demonic Covenants

Scripture reveals that participation in occult practices and false worship creates a form of spiritual covenant — a binding union with demonic entities. The prophets repeatedly used the language of adultery and harlotry to describe Israel's involvement with foreign gods (Ezekiel 16, Hosea 1-3). Just as God gave Israel a certificate of divorce for her spiritual adultery (Isaiah 50:1, Jeremiah 3:8), we can petition the Courts of Heaven to issue a formal certificate of divorce from every demonic entity and covenant to which we have been spiritually bound.

"Return, faithless Israel, declares the Lord, I will frown on you no longer, for I am faithful, declares the Lord, I will not be angry forever." — Jeremiah 3:12

A. Petition for the Divorce Certificate

Righteous Judge, I acknowledge before this Court that through my participation in New Age practices, kundalini, Red Lodge rituals, moon ceremonies, blood rites, sacred sexuality, and all associated occult systems, I entered into spiritual covenants and unions with demonic entities and powers. I entered these



unions in sin and ignorance. Today I stand fully awake to what occurred, and I ask for a formal legal severance.

On the basis of Your Word, I petition this Court to issue a Certificate of Divorce between me and every demonic entity, occult system, goddess spirit, serpent spirit, lunar spirit, earth spirit, and spiritual power to which I have been bound through these practices. I declare my intention to be permanently, legally, and irrevocably separated from every one of them. I renounce any claim they have made upon me as an initiate, as a vessel, as a priestess, as a devotee, or in any other role. I declare those unions ended, those titles revoked, and those relationships permanently severed.

B. Receiving the Certificate

By faith, I now receive from the Courts of Heaven a Certificate of Divorce from every demonic entity, occult power, kundalini spirit, goddess spirit, lunar spirit, serpent spirit, and spiritual system to which I have been bound. This certificate, issued on the basis of the blood of Jesus Christ and the repentance offered before this Court, constitutes a legal, permanent, and irrevocable severance.

I am no longer a devotee of the goddess. I am no longer an initiate of the mystery traditions. I am no longer a vessel for kundalini. I am no longer bound by Red Lodge covenant, moon ritual vow, or blood rite agreement. I am no longer spiritually married to or covenanted with any demonic entity or occult system. Every spiritual union formed through these practices is hereby dissolved — by the verdict of the Courts of Heaven, by the blood of the Lamb, and by the Name above all names: Jesus Christ.

These entities and systems are hereby served notice: the marriage is over. The covenant is cancelled. The certificate has been issued. You have no more legal claim upon me, my body, my children, my family line, my home, my finances, my ministry, or my destiny. I AM FREE.

Part Eleven: Declaration of Identity — Betrothed to Jesus Christ

Having been formally divorced from every demonic covenant and having received the verdict of the Courts of Heaven, we now make the most important declaration of all: our true identity and our true covenant. The Church — and each believer — is the Bride of Christ (Revelation 19:7-9, 2 Corinthians 11:2, Ephesians 5:25-32). Every false spiritual marriage renounced today is replaced by the only true and life-giving covenant: our betrothal to Jesus Christ.

"I am jealous for you with a godly jealousy. I promised you to one husband, to Christ, so that I might present you as a pure virgin to him." — 2 Corinthians 11:2



"Let us rejoice and be glad and give him glory! For the wedding of the Lamb has come, and his bride has made herself ready." — Revelation 19:7

A. Renouncing Every False Betrothal

Before this Court and before all of heaven, I renounce and dissolve every false betrothal, every spiritual marriage, and every covenant union formed between me and any demonic entity, occult power, or spiritual system. I renounce any vow of devotion or initiation that bound me as a bride or priestess of any false deity or spiritual tradition. I declare those vows null, void, and cancelled by the blood of Jesus Christ.

B. Declaring Betrothal to Jesus Christ

I declare before the Courts of Heaven, before all of creation, and before the enemy and all his powers: I BELONG TO JESUS CHRIST.

Lord Jesus, I receive Your betrothal. I accept Your covenant. I declare that I am Yours — body, soul, and spirit. You paid for me with Your own blood. You loved me before I knew You. You pursued me even while I was ensnared. And now I come to You — free from every other covenant — and I give myself fully and completely to You as Your beloved bride.

I receive the white robe of Your righteousness (Revelation 19:8). I receive the ring of Your covenant. I receive the name You have given me — Beloved, Redeemed, Chosen, Set Apart, Bride of Christ. I reject every false name, every false identity, every title given to me by occult systems. I am not a high priestess. I am not a devotee. I am not an initiate. I am not a vessel for spirits.

I AM THE BRIDE OF CHRIST. I am a daughter/son of the Most High God. I am a co-heir with Jesus Christ. I am a temple of the Holy Spirit. I am beloved and I am free.

Lord Jesus, I invite You to be the Lord of every part of my life previously given to other spiritual powers. Take Your rightful place as Husband, Protector, Provider, and King. Let this be the day our betrothal is renewed and established — clean, legal, free, and uncontested in every realm. I am Yours. You are mine. And nothing — no power, no entity, no past covenant — can separate me from Your love (Romans 8:38-39).



C. Declaration Over Children and Generations

I declare over my children and all future generations: they belong to Jesus Christ. They are not the inheritance of demons or generational spirits. They are the inheritance of the Lord (Psalm 127:3). I dedicate them to Him now — fully, freely, and forever. Let every generation that follows me know the love of Jesus Christ. Let the generational line of bondage end here, and let a generational line of freedom, blessing, and covenant love with Jesus Christ begin — today, sealed by His blood. Amen.

Part Twelve: Closing Prayer

Father God, I thank You for Your faithfulness. I thank You that You drew me out of darkness and into Your marvellous light (1 Peter 2:9). I thank You for the price Jesus paid so that I could stand before You clean, forgiven, and free. I thank You for the verdict of Your Courts. I thank You for the certificate of divorce from every demonic covenant. I thank You for receiving me as Your beloved bride.

I commit to renewing my mind through Your Word, to surrounding myself with a Spirit-filled community, and to maintaining this freedom through prayer, worship, and walking in obedience. I ask that You send wise and trustworthy people alongside me in this season of healing and restoration.

Thank You, Lord, that whom the Son sets free is free indeed (John 8:36). I receive that freedom now. In the precious and powerful Name of Jesus Christ, Amen.



Afterword: Recommended Next Steps

Freedom is a journey. This prayer is a powerful beginning, but ongoing discipleship and ministry may be needed. Consider the following steps:

1. Physically remove and destroy any objects connected to these practices: crystals, oracle cards, ritual tools, books, statues, or altar items. (Acts 19:19)
2. Seek out a trusted deliverance minister or Spirit-filled pastor who can walk with you through any remaining areas of bondage.
3. Renew your mind daily through Scripture. Romans 12:2 is key — transformation comes through the renewing of the mind.
4. If symptoms of spiritual pressure return, stand firm and remind the enemy aloud that the Courts of Heaven have ruled against him, the curses are broken, and your certificate of divorce has been legally issued.
